
ORDER FOR WRIT OF SPECIAL ELECTION

The Petitioner, the Board of Supervisors of Westmoreland County, Virginia, by counsel, filed a Petition for Entry of an Order of Writ of Special Election requesting that this Honorable Court issue a Writ of Special Election ordering that a special election be held in Westmoreland County, Virginia on Tuesday, November 4, 2025, to fill the unexpired term of the Treasurer of Westmoreland County. It appearing to the Court from the Petition that Sue N. Jones was elected at the November 7, 2023, general election to serve a four-year term as Treasurer of Westmoreland County commencing January 1, 2024, and that Sue N. Jones has submitted her resignation in writing to the Westmoreland County Board of Supervisors effective June 30, 2025, creating a vacancy in the Office of the Clerk; that, pursuant to Section 24.2-228.1, Bonnie S. Self, Chief Deputy Treasurer, will be sworn in by this Court on July 1, 2025, to perform the duties of the Treasurer of Westmoreland County.

Upon consideration of the Petition and the law, and with the requirements of law being met, it is hereby ORDERED and a Writ of Special Election ISSUED, as follows:

Pursuant to Sections 24.2-228.1, 24.2-682, and 24.2-683 of the Code of Virginia (1950), as amended, the Court hereby issues this Writ of Special Election and ORDERS and directs the Electoral Board of Westmoreland County, Virginia to conduct a special election to fill the unexpired term ending December 31, 2027, of the office of the Treasurer of Westmoreland County, Virginia, on Tuesday, November 4, 2025, in the same or similar manner and at the same or similar places as will be executed for the general elections.

It is ORDERED that the Electoral Board and the Registrar of Westmoreland County, Virginia, observe the legal mandates and directives set forth in Title Section 24.2, including but not limited to Sections 24.2-681 through 24.2-683, of the Code of Virginia, when conducting the

It is ORDERED that the General Registrar of Westmoreland County, Virginia, in accordance with Section 24.2-683 of the Code of Virginia, post a copy of this Writ of Special Election on the office website of Westmoreland County, Virginia, and have a notice of special election published at least once in a newspaper of general circulation in Westmoreland County, Virginia, and at least 10 days before the special election takes place on November 4, 2025.

The Court also requests that those officers take any and all necessary action as may be required or permitted by law in furtherance of the holding of the special election on November 4, 2025.
